



#### 1. Overall Objective

The Project Coordinator will play a key role in strengthening Community-Based Organizations (CBOs) within in the Kunene and Erongo regions. The coordinator will focus on enhancing Environmental Impact Assessment (EIA) processes and advancing community agency. They will forge strong collaboration with the tourism industry and conservation partners such as SRT, TOSCO, EHRA, IRDNC, and other NACSO members to promote sustainable development and conservation efforts.

### 2. Key duties and responsibilities:

#### 2.1. EIA Strengthening:

- Develop and implement strategies to enhance EIA capacities within CBOs.
- Organize training workshops and capacity-building sessions on EIA processes and best practices.
- Provide technical support to CBOs in conducting EIAs and interpreting results.

### 2.2. Collaboration and Partnerships:

- Establish and maintain strong relationships with the tourism industry and conservation organizations.

- Prepare and submit regular project reports to the Senior Coordinator and funding bodies.

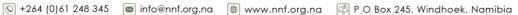
### 2.4. Community Engagement:

- Strong network within the tourism industry and conservation organizations in Namibia.


